

**MEMORANDUM OF UNDERSTANDING  
BETWEEN**

**S.V. INFOWAYS, Dealers in Computer, Pheripherals and Consumables,  
Mysuru - 570009**

This MOU made and entered into on 27th July, 2022, between the JSS Law College, Autonomous, Mysuru (hereinafter called JSSLC) situated at New Kantharaje Urs Road, Kuvempunagar, Mysuru-570023, Karnataka, an Autonomous Law College affiliated to Karnataka State Law University, Hubballi and S.V. INFOWAYS, Dealers in Computer, Pheripherals and Consumables, # 1, 4<sup>th</sup> Main, Kamakshi Hospital Road, Saraswathipuram, Mysuru - 570009.

**OBJECTIVES OF THE MOU**

The objectives of this Memorandum of Understanding are:

- a) To facilitate and effectively implement the environmentally sound management of the e-waste by S.V. INFOWAYS.
- b) To promote interaction between JSSLC and S. V. INFOWAYS in mutually beneficial areas.
- c) To make easy the Disposal and Collection of all Types of Electronic wastes.
- d) To jointly collaborate in conducting Special Talks and Lectures on the effective management of e-wastes.
- e) To reduce, reuse and re-cycle e-wastes without causing harm to nature through the vendors.

**PROPOSED MODES OF COLLABORATION:**

JSSLC and S.V.INFOWAYS propose to collaborate through

- a) S.V.INFOWAYS to provide adequate facilities for the disposal and management of e-wastes from JSSLC.
- b) S.V.INFOWAYS to do the same in an eco-friendly manner.



## **1. FINANCIAL DETAILS**

The cost for disposal and management of e-wastes shall be decided from time to time on the basis of mutually agreed terms and conditions between JSSLC and S.V. INFOWAYS.

## **2. CONFIDENTIALITY**

During and for a period of three years from the date of disclosure, each party agrees to consider as confidential all information disclosed by the other party in written or tangible form or, if orally disclosed, confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.

## **3. NON-EXCLUSIVITY**

The relationship of the parties under this MOU shall be non-exclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

## **4. TERMS AND TERMINATION**

This MOU, unless extended by mutual written agreement of the parties, shall expire three years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligation of the participants' confidentiality or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

## **5. RELATIONSHIP**

Nothing in this MOU shall be construed to make a party a partner, an agent or legal representative of the other for any purpose.

## **6. ASSIGNMENT**

It is understood by the parties herein this MOU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.



## 7. COSTS OF THE MOU

No cost is involved in this MOU.


## 9. SIGNED IN DUPLICATE
