

**MEMORANDUM OF UNDERSTANDING
BETWEEN**

JSS Law College, Autonomous, Mysuru– 570023

AND

JSS Science and Technology University, Mysuru

This MOU made and entered into on 25th July, 2022, between the JSS Law College, Autonomous, Mysuru (hereinafter called JSSLC) situated at New Kantharaje Urs Road, Kuvempunagar, Mysuru-570023, Karnataka, an Autonomous Law College affiliated to Karnataka State Law University, Hubballi and JSS Science and Technology University, JSS TI Campus, Manasagangothri, Mysuru – 570006 (hereinafter called JSSSTU).

OBJECTIVES OF THE MOU

The objectives of this Memorandum of Understanding are:

- a) To provide a formal basis for sharing the play ground between JSSLC and JSSSTU.
- b) To promote interaction between JSSLC and JSSSTU in mutually beneficial areas.
- c) To conduct Workshops, Seminars and symposiums and other programs jointly on various topics on Sports related activities.
- d) To jointly collaborate in conducting competitions and sports events for overall development of the colleges.
- e) To use infrastructure of JSSSTU pertaining to Physical Education and Sports.

PROPOSED MODES OF COLLABORATION:

JSSLC and JSSSTU propose to collaborate through

- a) JSSSTU will provide its playground infrastructure to conduct sports events for students.
- b) JSSLC and JSSSTU will provide for competitions to be conducted in the areas of Law, Commerce and Management, Engineering and allied Subjects.
- c) JSSLC and JSSSTU may conduct indoor sports activities, Conferences, Seminars, Symposiums, Workshops and many more in the relevant inter-disciplinary areas.

1. FORMS OF PROGRAMMES

The form of any of the said programs (hereinafter referred to as "Program") will be subject to mutual agreement into by the parties but may also include the following:


- a) **In their own existing facilities:** The conduct of programs individually by each party or concurrently by both in mixed groups at their own facilities with regular exchanges of results.
- b) **Organizing Regional and National Level Sports Events:** The performance of publishing by the technical personnel of both parties working together in the facilities of one party or in mixed groups at the facilities supported/ sponsored by either party.
- c) **Third Party:** The performance of sports competitions and events by the parties together with one or more third parties.

2. FINANCIAL DETAILS

The cost for conducting any programme /activity shall be decided from time to time on the basis of mutually agreed terms and conditions between JSSLC and JSSSTU.

3. CONFIDENTIALITY

- a) During and for a period of three years from the date of disclosure, each party agrees to consider as confidential all information disclosed by the other party in written or tangible form or, if orally disclosed, confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.
- b) The obligations shall not extend to any confidential information for which the receiving party can prove that this information:

- i. Is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.
- ii. Is already known to the receiving party.
- iii. Is received from a third party having no obligations of confidentiality to the disclosing party.

4. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

5. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire three years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligation of the participants under any research Agreement, confidentiality or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

6. RELATIONSHIP

Nothing in this MOU shall be construed to make a party a partner, an agent or legal representative of the other for any purpose.

7. ASSIGNMENT

It is understood by the parties herein this MOU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.


